MONTAGE FOR AG, INC., IS A CALIFORNIA CORPORATION. WE, MONTAGE FOR AG, INC., OUR AFFILIATES AND SUBSIDIARIES, (COLLECTIVELY, “MONTAGE™”, “WE,” “US,” OR “OUR”) ARE COMMITTED TO RESPECTING YOUR PRIVACY. YOUR ABILITY TO MAKE INFORMED DECISIONS ABOUT YOUR INFORMATION IS IMPORTANT TO US. THIS SECTION PROVIDES DETAIL ON HOW WE COLLECT, USE, AND STORE INFORMATION AND DATA THAT WE RECEIVE FROM USERS.

1. THIS POLICY AND ACCEPTANCE

THIS IS THE PRIVACY POLICY (THE OR THIS “POLICY”) THAT APPLIES TO YOUR USE OF THE SITES. BY VISITING, USING, OR OTHERWISE INTERACTING WITH THE SITES, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS POLICY

2. YOUR INFORMATION

WE GATHER AND STORE THREE TYPES OF INFORMATION ABOUT USERS THAT ARE SUBJECT TO THIS POLICY.

○ INFORMATION YOU PROVIDE TO US.

YOU WILL BE ASKED TO VOLUNTARILY SUBMIT INFORMATION TO US WHEN YOU CREATE AN ACCOUNT, AND AT VARIOUS OTHER TIMES AS YOU USE THE SITES. THIS INFORMATION INCLUDES, BUT IS NOT LIMITED TO, YOUR NAME, DATE OF BIRTH, LOCATION, E-MAIL ADDRESS, PHYSICAL ADDRESS, AND PHONE NUMBER. THIS INFORMATION ALLOWS US TO SETUP, MAINTAIN, AND TRACK YOUR ACCOUNT.

○ INFORMATION WE OBSERVE ABOUT YOU.

WE KEEP TRACK OF HOW YOU USE THE SITES AND THE SERVICES PROVIDED THROUGH THE SITES. WHEN YOU ACCESS THE SITES OR THE SERVICES WE MAY COLLECT INFORMATION ABOUT YOUR METHOD OF ACCESS, LOCATION, IP

ADDRESS, AND/OR THE PAGES THAT YOU VISIT. IN ADDITION, WE STORE CERTAIN INFORMATION FROM YOUR BROWSER USING “COOKIES.” (SEE BELOW FOR MORE INFORMATION ON COOKIES). THIS INFORMATION HELPS US TO MONITOR WHAT’S WORKING AND WHAT’S NOT SO THAT WE CAN CONTINUALLY IMPROVE THE SITES AND THE SERVICES.

○ **INFORMATION WE RECEIVE FROM THIRD PARTIES.**

WE OPERATE THIRD PARTY APPLICATIONS THAT INTERACT WITH THE SERVICES OR THE SITES (THE “APPLICATIONS”). WHENEVER YOU VISIT, USE, OR INTERACT WITH THE APPLICATIONS, WE MAY RECEIVE INFORMATION FROM THE THIRD PARTY OPERATOR OF THE APPLICATIONS, INCLUDING INFORMATION ABOUT THE ACTIONS YOU TAKE USING THE APPLICATIONS. THIS INFORMATION HELPS US TO IMPROVE THE INTERACTION BETWEEN THE APPLICATIONS AND THE SERVICES.

THIS INFORMATION IS IMPORTANT TO OUR ABILITY TO PROVIDE THE SERVICES, AND IT IS IMPORTANT TO YOU THAT THIS INFORMATION BE KEPT PRIVATE. THROUGHOUT THIS POLICY WE WILL REFER TO THIS INFORMATION COLLECTIVELY AS (“YOUR INFORMATION”).

3. USE OF YOUR INFORMATION

WE COLLECT YOUR INFORMATION SO THAT WE CAN DELIVER THE SERVICES SAFELY, EFFICIENTLY, AND IN THE HIGHEST POSSIBLE QUALITY. WE WILL USE YOUR INFORMATION TO CREATE AND MAINTAIN YOUR ACCOUNT, AND TO IMPROVE THE SERVICES. WE ONLY COLLECT YOUR INFORMATION BECAUSE YOU ARE VOLUNTARILY SUBMITTING SUCH INFORMATION TO US IN ORDER TO USE THE SERVICES.

WE USE THIRD PARTY SERVICES, SUCH AS GOOGLE ANALYTICS TO GATHER INFORMATION ABOUT YOUR VISIT TO OUR SITE, SUCH AS THE PAGES AND INFORMATION YOU VIEWED. SOME OF THESE SERVICES MAY GATHER INFORMATION ABOUT THE DOMAIN NAME FROM WHICH YOU ARRIVED AT OUR SITE.

WE’RE NOT IN THE BUSINESS OF SELLING YOUR INFORMATION, SO WE WON’T.

THROUGHOUT THE COURSE OF OUR PROVISION OF OUR SERVICES TO YOU, WE MAY DELEGATE OUR AUTHORITY TO COLLECT, ACCESS, USE, AND DISSEMINATE YOUR INFORMATION. IT IS THEREFORE NECESSARY THAT YOU GRANT THE THIRD PARTIES WE USE IN THE COURSE OF OUR BUSINESS THE SAME RIGHTS THAT YOU AFFORD US UNDER THIS PRIVACY POLICY. FOR THIS REASON, YOU HEREBY AGREE THAT FOR EVERY AUTHORIZATION WHICH YOU GRANT TO US IN THIS PRIVACY POLICY, YOU ALSO GRANT TO ANY THIRD PARTY THAT WE HIRE, CONTRACT, OR OTHERWISE RETAIN THE SERVICES OF FOR THE PURPOSE OF PROVIDING OPERATING, MAINTAINING, REPAIRING, OR OTHERWISE IMPROVING OR PRESERVING OUR SITE.

WE MAY SHARE YOUR PERSONAL INFORMATION WITH OUR SUBSIDIARIES, JOINT VENTURES, OR OTHER COMPANIES UNDER COMMON CONTROL, IN WHICH CASE WE WILL REQUIRE THEM TO HONOR THIS PRIVACY POLICY. WE MAY ALSO SHARE YOUR PERSONAL INFORMATION WITH ANY COMPANY THAT ACQUIRES OUR COMPANY OR SOME OR ALL OUR ASSETS IN ANY SALE, MERGER, BANKRUPTCY PROCEEDING OR OTHER TRANSACTION. THAT COMPANY WILL POSSESS THE PERSONAL INFORMATION COLLECTED BY US AND WILL ASSUME THE RIGHTS AND OBLIGATIONS REGARDING YOUR PERSONAL INFORMATION AS DESCRIBED IN THIS PRIVACY POLICY. FINALLY, WE MAY SHARE YOUR PERSONAL INFORMATION IF YOU PROVIDE US PRIOR CONSENT TO DO SO.

YOU AGREE NOT TO HOLD US LIABLE FOR THE ACTIONS OF ANY OF THESE THIRD PARTIES, EVEN IF WE WOULD NORMALLY BE HELD VICARIOUSLY LIABLE FOR THEIR ACTIONS, AND THAT YOU MUST TAKE LEGAL ACTION AGAINST THEM DIRECTLY SHOULD THEY COMMIT ANY TORT OR OTHER ACTIONABLE WRONG AGAINST YOU. THE FOLLOWING IS A NON-EXHAUSTIVE LIST OF OTHER ENTITIES THAT WE MAY STORE, SHARE, OR TRANSFER YOUR INFORMATION WITH:

4. PROTECTION OF YOUR INFORMATION

WE USE COMMERCIALY REASONABLE PHYSICAL, ELECTRONIC, AND PROCEDURAL MEASURES TO SAFEGUARD YOUR INFORMATION AGAINST LOSS, THEFT AND UNAUTHORIZED USE, DISCLOSURE, OR MODIFICATION. WE LIMIT ACCESS TO YOUR INFORMATION TO EMPLOYEES WHOM WE BELIEVE REASONABLY NEED YOUR INFORMATION TO PROVIDE SUPPORT, PRODUCTS, OR SERVICES TO YOU OR TO FULFILL THEIR ROLES WITHIN OUR ORGANIZATION.

PLEASE BE AWARE THAT NO SECURITY MEASURES ARE PERFECT OR IMPENETRABLE. WE CANNOT CONTROL THE ACTIONS OF OTHERS WITH WHOM YOU SHARE YOUR INFORMATION, WHETHER OVER THE SITES, THROUGH THE SERVICES, OR ELSEWHERE ON THE INTERNET. 7. THIRD PARTY PAYMENT PROCESSOR
